**RESOLUTION 2024.006**

**A RESOLUTION EXTENDING THE APPOINTMENT OF WILLIAM A. HALL AS THE CITY ADMINISTRATOR FOR THE CITY OF LAKE CITY AND OTHER MATTERS INCIDENT THERETO**

**WHEREAS**, William A. Hall (“Mr. Hall”) currently serves as the City of Lake City (“Lake City”) City Administrator pursuant to the City Council’s appointment in March 2022 and subsequent Employment Agreement (“Agreement”) executed March 2022; and,

**WHEREAS**, the term of the Agreement expires in March 2024;

**WHEREAS**, Mr. Hall has expressed a desire to continue to serve as the City Administrator.

**NOW, THEREFORE, BE IT RESOLVED BY CITY COUNCIL, THAT:**

1. The City Council of the City of Lake City extends the appointment of William A. Hall as the City Administrator. Legal counsel of the City and the Mayor are charged with, authorized, and actions ratified to negotiate and cause to be executed by the Mayor an agreement extending the term of William A. Hall as City Administrator for a two-year period in terms analogous to those previously agreed upon. Legal counsel and the Mayor may negotiate and execute an agreement as found fit and the execution of the final form of an agreement shall be considered as the assent of the City Council.
