BUDGET WORKSESSION:

PRESENTATION

City Administrator William A. Hall presented the City’s annual budget plan to Council with an overview of the proposed budget for projected revenue and expenses along with future service plans for Fiscal Year 2022-2023. The proposed budget includes 3% cost of living increases for employees, 1% Christmas payout bonuses, with 15 paid holidays. The budget was balanced without increasing taxes.

The councilmembers present asked several questions about proposed rates, fees, and identified projects.
